#### Seats for the Yom Tovim - Please Read

This year Rosh Hashana falls on September 30th & October 1st and Yom Kippur on October 9th

The following procedures MUST be adhered to in order to obtain your High Holiday seats:

- 1. All past dues and obligations (building fund, dinner ads, appeals, luncheon sponsorships, cubby holes, etc.) must be brought up-to-date.
- 2. The current first quarter dues and any current building fund obligations for 5780 must be paid prior to obtaining your High Holiday seats.
- 3. The enclosed High Holiday seating application must be completed and any extra seats must be paid for at time of selection.
- 4. If a financial problem exists, please discuss it with the President, Vice President, or our Financial Secretary as soon as possible.
- 5. If you will not be using any of your seats this year, please let us know so that we may assign them to others. Please note on the bill if you will want any of those seats back in future years and they will be kept on reserve for your use next year.
- 6. Seats will be held for members only until <u>September 20, 2019</u>. After that date, all remaining seats will be made available to other members, new members, associates and non-members wishing to purchase seats.
- 7. Members seeking to reserve more or less seats than last year have to see James Katz, chairman of the Seating Committee, after paying your dues, at the shul. He will be available for seating (but not for payment of monies due to the shul) beginning after Ma'ariv on Monday, September 3, 2019. Additional dates and times will be announced.
- 8. All payments must be given to our Financial Secretary, Rob Goldfarb, **BEFORE** you see Mr. Katz or you will not get seats.

### **Article III: Membership Eligibility**

#### Section 1:

All persons of Jewish faith, 18 years of age and more, of good moral character, who believe in and who are in accord with the aims and principles of Ohaiv Yisroel of Blueberry Hill shall be eligible for membership; but NO person shall be a member until such person is accepted as such at a general special meeting of the Congregation. Voting privileges are reserved to members in good standing, i.e. those not suspended from membership. Each member is entitled to one vote at all meetings of the Congregation and on its committees. #### Article III: Membership Eligibility

#### Section 1:

All persons of Jewish faith, 18 years of age and more, of good moral character, who believe in and who are in accord with the aims and principles of Ohaiv Yisroel of Blueberry Hill shall be eligible for membership; but NO person shall be a member until such person is accepted as such at a general special meeting of the Congregation. Voting privileges are reserved to members in good standing, i.e. those not suspended from membership. Each member is entitled to one vote at all meetings of the Congregation and on its committees. Where a husband and wife attend such meetings, each shall be entitled to one-half vote. Except as required by law no proxy vote shall be allowed.

#### **Associate Members**

#### Section 11:

All provisions of Article III section 1 apply, except that an Associate Member does NOT have voting privileges. Associate Members shall pay dues on a semi-annual basis on September 1 and March 1. Associate Members are not required to contribute to the Building Fund. Associate Membership is limited to individuals who DO NOT regularly attend Congregation Ohaiv Yisroel for Shabbat morr ing services. The cost for High Holiday seats for Associate Members shall be the same as that charged for Non-Members.
